Dear Students,

The last two years of Covid-19 and the consequent upheaval have been challenging, to say the least. We are fully cognizant of the needs of students who have been impacted by the social and economic crisis brought on by the pandemic.

At the outset, we would like to take this opportunity to thank you for keeping your trust intact in J.D. Birla Institute. We understand your concerns and our institution is trying its level best to ensure that best possible resources and facilities are provided to the students to help them accomplish their scholastic and co-scholastic goals. You would appreciate that our institution has successfully ensured that online classes & engagement activities continue for our students and all round development does not stop in spite of unprecedented challenges and concerns.

Additionally, in wake of the unprecedented situation due to COVID-19, J.D. Birla Institute has taken proactive caring steps with students' best interest at the core of all our decisions, without compromising academic delivery, examination and result declaration. Our institution keeping the interests of the students in mind, has not increased the fees for academic year 2020-21. We have also provided complete or partial fee waiver to bonafide applicants, besides the general reduction in fees during the pandemic time.

J.D. Birla Institute provided full cooperation in the execution & implementation of live projects, virtual laboratory sessions, while expanding and facilitating library resources. The Institute consistently offered not just academic support, but also organized co-curricular and cultural activities to keep students in healthy spirit.

The Institute has been incurring and continues to incur substantial expenditure. There has been no reduction in the salary of teachers and all other staff. On the contrary, the salaries have had to be increased by an average of 20% along with every teacher being given a separate monthly amount over and above their salaries for covering the costs of internet connections and other expenses on account of online classes. The Institute, besides providing training to the teachers and maintaining the online facility, had to cater to the costs for purchase of bandwidth by the teachers as well.

We at J.D. Birla Institute have invested substantially in digital transformation of all operations, keeping up with global trends and putting our students' best interests primary. All such measures have proved to be additional expenditures. Moreover, despite the virtual mode having been in operation till now, expenditure towards regular upkeep, periodical maintenance and repair work of the building, the facilities and amenities thereof has also been undertaken by the Institute. Additionally, the Institute has kept the premises regularly sanitized and has been all set to receive students as per State Government guidelines.

The West Bengal State Government has issued a notification dated 30th January, 2022 (Order No. 753/XX-ISS/2M-22/2020) mandating opening of colleges and universities from 3rd February, 2022 onwards. Therefore, the Institute now has been incurring all regular expenses in order to ensure a smooth transition back to classes in face to face mode for the students. Additionally, the Institute has to continue to incur the costs for keeping the alternative online module in operation. This is an inevitable cost that needs to be borne as the Institute has to account for a change in the current situation and have to continue the option of a hybrid mode of classes. Therefore, the Institute has had to incur more expenses than it did previously and is forced to increase its fee in order to meet the increasing costs.

The Institute can only keep up with its various obligations when the fees is received in a timely manner by the Institute. We therefore seek your understanding and cooperation and expect all the students to clear all dues latest by 15th March 2022.

We are committed to the wellbeing and safety of everyone in our community and shall abide by our resolve to provide high-quality education so that you can succeed, progress, and achieve your career goals. Our teachers have left no stone unturned in providing an unbroken learning process. We solicit your kind cooperation in continued smooth running.

We are eagerly waiting to receive you at campus.
